





What is the Role of Second House or bhava and lord, Fourth House or bhava Lord, eighth House or bhava or Lord, Ninth House or Bhava Lord & Eleventh House or Bhava Lord in Inheritance in your Horoscope or Kundli(Birth Chart)?

#### What is the Role of your d4/varga chart or divisional chart analysis in your Porperty and legacy/inheritance Matters?


- The GOD's language of Vedic Astrology distributes information beautifully across the lagna and the divisional charts.


